TWO COMPLETE SETS OF PLANS ARE REQUIRED FOR SFR, including a plot plan showing all required setbacks which shall stay on file during construction. A full set of engineered foundation plans are required. All drainage issues shall be completed prior to a final inspection request. A minimum of 48 hours is required for review of SFR. Commercial projects require three sets of completed drawings stamped, signed and dated by the architect licensed by the State of Texas. A commercial site plan shall be submitted and reviewed through the Building Official's office prior to your commercial plan review or in conjunction with. Review time required for a commercial project is a minimum of two weeks. Separate permits are required for electrical, plumbing, HVAC and signs. This permit, after issuance date, becomes null and void if work or construction authorized is not commenced within 180 days or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.

**A Tree Removal Permit must be obtained to remove any Protected Tree within the City of Granbury. Please refer to an approved Tree Conservation Plan and Article 13 of the Zoning Ordinance for tree removal and tree protection requirements.**
