FEES:

- ALL CONTRACTORS must supply a copy of current driver's license.
- State licensing proof per trade
- Master Plumber: Must be licensed by the Texas State Board of Plumbing Examiners and must present copy of license.
- Master Electrician: Must be licensed by the Texas Department of Licensing & Registration and must present copy of license.
- ALL CONTRACTORS: Must submit either a \$5,000 Surety Bond <u>OR</u> Certificate of Insurance with a minimum of \$300,000 Personal Injury/Death & \$100,000 Property Damage showing The City of Granbury as the certificate holder, <u>Policy shall require 10 days' notice of cancellation.</u>
