

**RESOLUTION NO. 23-25**

**A RESOLUTION CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD ON NOVEMBER 7, 2023 FOR THE CITY OF GRANBURY FOR THE PURPOSE OF ELECTING A COUNCILPERSON PLACE FOUR (4) AND COUNCILPERSON PLACE SIX (6)**

**WHEREAS**, pursuant to Resolution No. 23-13 of the City of Granbury, Texas, adopted on August 1, 2023, a General Election was duly held on November 7, 2023, for the purpose of electing a Councilperson Place Four (4), and a Councilperson Place Six (6) for full terms; and

**WHEREAS**, said election was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law; and

**WHEREAS**, only duly qualified resident voters of the City of Granbury, Texas, voted at the General Election; and

**WHEREAS**, Section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11<sup>th</sup>) day after the Election date for the purpose of canvassing the election results; and

**WHEREAS**, official returns and tabulations from said election, attached hereto as Exhibit A, were received from the Hood County Elections Administrator as set out in the Joint Election Agreement signed and approved on August 1, 2023.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS THAT:**

**SECTION 1.**

All of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.

**SECTION 2.**

It is officially found and determined (Exhibit A) that in said election, each of the candidates received the following votes during early voting and on Election Day:

**COUNCILPERSON PLACE FOUR (4)**

Charles Beard	639
Brad Benson	623
Gary "Skip" Overdier	1,072

COUNCILPERSON PLACE SIX (6)

Greg Corrigan	1,183
Alex Wolf	1,081

**SECTION 3.**

The City Council of the City of Granbury approves and accepts the results of the said election, and therefore the following candidate is hereby elected: Greg Corrigan, Councilmember Place Six (6) for a full term.

In accordance with Article 11, Section 11 b of the Texas Constitution and Section 2.021 of the Texas Election Code, a runoff election is hereby required for the purpose of electing a Councilperson Place Four (4).

**SECTION 4.**

If any part or parts of this Resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.

**SECTION 5.**

It is hereby officially found and determined that the meeting at which this Resolution is passed, was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, and Local Gov't Code.


**SECTION 6.**
