

**RESOLUTION NO. 21-11**

**A RESOLUTION CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF A SPECIAL ELECTION RUNOFF HELD ON JULY 27, 2021, FOR THE CITY OF GRANBURY FOR THE PURPOSE OF ELECTING A COUNCILPERSON PLACE FIVE (5).**

**WHEREAS**, pursuant to Resolution No. 21-03 of the City of Granbury, Texas, adopted on May 10, 2021 and Resolution No. 21-04 of the City of Granbury, Texas, adopted on May 14, 2021, a special election was duly held on June 29, 2021, for the purpose of electing a Mayor, Place One (1) and Councilperson, Place Five (5) to fill the remainder of the unexpired three (3) year terms, or until the successors have been duly qualified; and,

**WHEREAS**, the official results of said election were canvassed with the adoption of Resolution No. 21-08 on July 6, 2021; and,

**WHEREAS**, pursuant to Article 11, Section 11b of the Texas Constitution and Section 2.021 of the Texas Election Code, a runoff election was required for the purpose of electing a Councilperson Place Five (5) and was ordered for July 27, 2021, with the adoption of Resolution 21-09; and,

**WHEREAS**, said special election runoff was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law; and

**WHEREAS**, Section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11<sup>th</sup>) day after the election date for the purpose of canvassing the election results; and

**WHEREAS**, official returns and tabulations from said special election runoff, attached hereto as Exhibit 'A', were received from the Hood County Elections Administrator as set out in the Contract for Election Services signed and approved on May 10, 2021.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS THAT:**

**SECTION 1.**

All of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.

**SECTION 2.**

It is found and determined, by the official election results attached hereto as Exhibit 'A', that in said election, each of the candidates received the following votes during early voting and on election day:

**COUNCILPERSON, PLACE FIVE (5)**

Steven Vale	388
Cathy Reidy	436
Cast Votes	824

**SECTION 3.**

The City Council of the City of Granbury approves and accepts the results of the said election, and therefore the following candidate is hereby elected: Cathy Reidy, Councilperson Place 5.

**SECTION 4.**

If any part or parts of this Resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.

**SECTION 5.**

It is hereby officially found and determined that the meeting at which this Resolution is passed, was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, and Local Gov't Code.

**SECTION 6.**

This Resolution shall be in full force and effect from and after the date of its passage.
