

**RESOLUTION NO. 23-29**

**A RESOLUTION CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION RUNOFF HELD ON DECEMBER 9, 2023, FOR THE CITY OF GRANBURY FOR THE PURPOSE OF ELECTING A COUNCILPERSON PLACE FOUR (4).**

**WHEREAS**, pursuant to Resolution No. 23-13 of the City of Granbury, Texas, adopted on August 1, 2023, a General Election was duly held on November 7, 2023, for the purpose of electing a Councilperson Place Four (4), and a Councilperson Place Six (6) for full terms; and

**WHEREAS**, the official results of said election were canvassed with the adoption of Resolution No. 23-25 on November 16, 2023; and,

**WHEREAS**, pursuant to Article 11, Section 11b of the Texas Constitution and Section 2.021 of the Texas Election Code, a runoff election was required for the purpose of electing a Councilperson Place Four (4) and was ordered for December 9, 2023, with the adoption of Resolution 23-26; and,

**WHEREAS**, said General Election Runoff was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law; and

**WHEREAS**, Section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11<sup>th</sup>) day after the election date for the purpose of canvassing the election results; and

**WHEREAS**, official returns and tabulations from said general election runoff, attached hereto as Exhibit 'A', were received from the Hood County Elections Administrator as set out in the Contract for Election Services signed and approved on August 1, 2023.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS THAT:**

**SECTION 1.**

All of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.

**SECTION 2.**

It is found and determined, by the official election results attached hereto as Exhibit 'A', that in said election, the candidates received the following votes during early voting and on election day:

**SECTION 3.**

The City Council of the City of Granbury approves and accepts the results of the said election, and therefore the following candidate is hereby elected: Gary "Skip" Overdier, Councilperson Place Four (4) for a full term.

**SECTION 4.**

If any part or parts of this Resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.

**SECTION 5.**


