The following requirements must be met prior to the issuance of a **Snowcone Stand Permit**:

- a. Retail Food Establishment Permit – issued by Health Inspector, following pre-opening inspection
- b. Temporary Certificate of Occupancy – issued by Building Official
- c. Compliance with Building, Plumbing, Electrical, and Health Codes
- d. On-site parking as required by the Building Official (minimum of two) in addition to required parking for the primary use
- e. Written permission from the landowner if different than that of the snowcone stand operator
- f. Restroom facility or written permission from landowner or adjacent tenant to utilize restrooms
- g. Electrical permits and inspections, if needed- by Building Official
- h. Drawing/ sketch of site; indicating location of tables, chairs, and awnings detailing how they will be anchored and secured. Mobile home type straps/ anchors shall be used on all awnings (all 4 corners)
- i. A sign permit shall be obtained for all advertising, in accordance with Article 7- Sign Requirements of the City of Granbury Zoning Ordinance. Overnight storage of any vehicles with commercial advertising shall be parked in the furthest available parking space from street frontage. Overnight storage of vehicles must not encumber required parking spaces.
