Registration Valid for One Calendar Year (Jan 1st-Dec 31st)- Must Renew Annually

“Contractor” is defined as: Any person who installs, maintains, erects, consults, enlarges, alters, repairs, moves, improves, removes, converts, demolishes, Master Electrical Contractor, State Licensed Plumbing Contractor, Mechanical Contractor, General Contractor, Building Contractor, State Licensed Sprinkler Contractor, House Mover, State Licensed Fire Sprinkler Contractor, Sign Contractor, etc.

REQUIREMENTS:

- **ALL CONTRACTORS** must supply a copy of current driver’s license.
- State licensing proof per trade
- Master Plumber: Must be licensed by the Texas State Board of Plumbing Examiners and must present copy of license.
- Master Electrician: Must be licensed by the Texas Department of Licensing & Registration and must present copy of license.
- **ALL CONTRACTORS:** Must submit either a \$5,000 Surety Bond **OR** Certificate of Insurance with a minimum of \$300,000 Personal Injury/Death & \$100,000 Property Damage **naming The City of Granbury as the Certificate Holder.** Policy shall require 10 days’ notice of cancellation.

FEES:

Initial Registration Fee.....\$100.00

Renewal Registration Fee\$100.00

(Fees do not apply to Plumbing Contractors, Electrical Contractors, Mechanical Contractors, Fire Sprinkler Contractors, Fire Alarm Contractors, and Fire Suppression Contractors)

NOTICE: Contractors allowing occupancy prior to **ANY FINAL INSPECTION** issued by the City will result in revocation procedures against your contractor registration with penalties or fines as allowed by law (COG Ord. 3.16.004).

NOTE: A registered sign contractor must have a Master Electrician in his employ if electrical work is required. Solar Contractors must register as a General & Electrical Contractor.
