

RESOLUTION NO. 19-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS REQUESTING THAT THE TEXAS TRANSPORTATION COMMISSION TAKE ACTION TO INCLUDE THE U.S. 377 IMPROVEMENT PROJECT IN HOOD COUNTY IN THE 2020 UNIFIED TRANSPORTATION PLAN AND TAKE ACTION TO COMPLETE PROJECT; AUTHORIZING THE CITY SECRETARY TO FORWARD THE RESOLUTION TO TXDOT; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Granbury, Texas (“City”) is a home rule municipality chartered under the constitution and laws of the State of Texas; and

WHEREAS, the City is situated in Hood County, Texas and thus uniquely affected by the transportation issues in Hood County; and

WHEREAS, a flowing transportation system between the City and the Dallas/Fort Worth Metroplex is a vital component to the health and growth of the City; and

WHEREAS, the City recognizes the important work Texas Department of Transportation (TxDOT) performs for the State of Texas including the advancement of transportation movements within Hood County and other surrounding counties; and

WHEREAS, the City supports any and all actions taken by the Texas Transportation Commission to complete the design, land acquisition and ultimate construction activities for the expansion of U.S. 377 from Texas State Highway 167 (SH 167) to east of Texas State Highway 144 (SH 144) (the Project) as it will provide for added safety and needed aid in relieving congestion to the City of Granbury and surrounding areas; and

WHEREAS, the Project is currently included in the North Central Texas Council of Governments (NCTCOG) Mobility Plan as a Regionally Significant Arterial and has been included TxDOT Unified Transportation Plans (UTP) in the past.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANBURY, TEXAS, that:

SECTION 1:

The findings and declarations contained in the Preambles of this Resolution are incorporated herein as part of this Resolution.

SECTION 2:

The City Council hereby finds and determines that it is wise, expedient, necessary and advisable and in the public interest and benefit that the City formally request that TxDOT include the U.S 377 project in the 2020 Unified Transportation Plan and take all actions to complete the design, land acquisition and ultimate construction activities for the expansion of this roadway through Granbury.


SECTION 3:
